



Terms and Conditions

of Humbug Extended Fishing Charters

1. BOOKINGS:

- 1.1. All bookings require payment of a 20% non-refundable deposit on confirmation of the booking. Failure to pay the deposit may result the booking to be cancelled.
- 1.2. Final payment must be made no later than 10 days prior to departure. Failure to make final payment within this time may result in the booking being cancelled.
- 1.3. Children under the age of 18 must be accompanied by an adult.

2. REFUNDS:

- 2.1. All deposits and final payments for trips are non-refundable.
- 2.2. If a trip is cancelled any monies paid will be applied towards re-booking a trip.
- 2.3. Cancellation must be made at least 3 days prior to the scheduled trip, failing which, clients will lose the right to re-book the trip.

3. SAFETY

- 3.1. Instructions or advice given by the Skipper or Crew on matters of safety must be observed by all passengers on board and passengers must, at all times, take all reasonable precautions for their own and others safety.
- 3.2. Neither the Skipper nor Crew accept any liability for any accident or injury incurred by any passenger on board the vessel engaged in fishing, angling, diving, sightseeing, photography, filming, whilst in transit or similar activities, caused by the actions of any other passenger on board howsoever occurring.

4. TURBULENT WEATHER:

- 4.1. The Northern Territory can experience rough weather conditions. On such occasions, the skipper has the discretion to decide whether to commence a trip or, if a trip has commenced, to seek shelter during a trip.
- 4.2. If the trip is cancelled due to bad weather no refund will be given. However passengers will be given the option re-book another trip. The full amount paid will be

applied towards the rescheduled trip. The rescheduled trip will be for equivalent value.

5. **INSURANCE**

Humbug Extended Fishing Charters recommends that all passengers purchase comprehensive travel insurance, including cancellation cover, at the time of booking. The insurance will protect the passengers against an emergency that may cause a passenger to cancel their trip or leave from a trip while it is in progress.

Humbug Fishing insurance does not cover your vessel whilst on a charter with us. Please share this info with all vessel owners on this charter.

6. **MEDICAL / DIETARY REQUIREMENTS:**

Humbug Extended Fishing Charters caters for all meals during the trip. Any passengers with special dietary needs must inform Humbug Extended Fishing Charters with the final payment.

It is the responsibility of the passengers to inform Humbug Extended Fishing Charters of any medical requirements prior to departure. All passengers must be responsible for their own medication.

7. **LIABILITY**

Humbug Extended Fishing Charters takes no responsibility for any injuries sustained to persons or damage to personal property, whilst boarding the vessel, for the duration of trip, or disembarking from the vessel unless such injury is caused by the wilful neglect of the owner or its employees. **Passengers board the vessel at your own risk.**

8. **PHOTOGRAPHY**

Humbug Extended Fishing Charters may take photographs on the vessel and publish the photographs on its website or in television or written media advertising for promotional purposes. Please advise Humbug Extended Fishing Charters if you do not wish any photographs to be taken for promotional purposes.
